## ARE YOU READY FOR NEW RULES FOR BUSINESS WITH THE EU?

## **Urgent message from the Business Secretary**

There is just over **a month to go** until the end of the transition period and there will be new rules to follow from 1 January 2021 onwards. As Business Secretary, I urge you to **ACT NOW** to avoid your business operations being interrupted when the transition period ends.

As a business in the chemicals sector, you can find out what you need to do by going to gov.uk/chemicals-2021. The top actions you can take now to prepare are:

 Check what actions you need to take under UK REACH, EU REACH and other chemical regulations to continue to manufacture and place chemicals on the Great Britain, Northern Ireland and EU markets.

Your business may face delay, disruption or administrative costs to trading goods between UK and EU if you do not comply with chemicals regulations from 1 January 2021. If you want to place chemicals on the Great Britain, Northern Ireland and EU markets from 1 January 2021, you must check the new rules on: hse.gov.uk/brexit

2. Check the new rules on importing and exporting goods between the EU and Great Britain from 1 January 2021. Different rules will apply in Northern Ireland.

Your business could face delays, disruption or administrative costs if you do not comply with new customs procedures from 1 January 2021.

Check if a visa or work permit is required to travel to the EU for work purposes and apply if necessary.

You may face delays or refusal at border when travelling for business if you do not comply with the immigration requirements of the EU27 if travelling from 1 January 2021.

4. If you are moving goods into, out of, or through Northern Ireland, check the latest guidance.

At the end of the transition period, the Northern Ireland Protocol comes into force. There will be special provisions which only apply in Northern Ireland so if you move goods into, out of, or through Northern Ireland make sure you check the latest guidance at: gov.uk/northern-ireland-trade
