These are exciting times for Catalyst, as it has accelerated its growth since Covid, having secured funding to enhance its facilities and has another major bid in progress with the National Lottery Heritage Fund, with the goal to re-invent its exhibitions and widen its visitor appeal. It already now works with c220 schools at Key Stages 1-3, who attend educational field visits, besides the public and corporate clients. Reporting to the new CEO you will be an integral part of the overall team; this is great opportunity for you to make your mark in the organisation to provide accurate finance information and continue to develop and improve the financial and operational systems supporting the next phase of future growth.

This is a hands-on and varied role, with a wide span of responsibilities, including the upkeep of day-to-day financial operations, including invoicing, payments, VAT, banking, gift aid etc., through to producing the full monthly management accounts, budgets, and forecasts to support management and the Board's decision-making, plus drafting the annual accounts liaising with the Auditors and other Third Parties. You will provide financial information relating to significant grant-funding claims when required and be capable of project managing the successful financial aspects of bid wins. Additionally, you will continually look to develop finance processes and procedures and assist with further integration of IT systems. Your role will involve you working collaboratively with the wider Catalyst team, and third-party service providers, for such as payroll, HR, IT, Telephony etc.

The successful applicant will likely be a qualified AAT (ACCA, CIMA or ACA) who will relish this broad-based role and wants to be part of this vibrant, local Charity, who seeks to work on a permanent, flexible Part Time basis on site (25 hours).
